ORDER:-

The Director of Medical Education in the letters read above, has sent the proposal for construction of additional Library Building in Government Vellore Medical College, Vellore.

2. The Director of Medical Education has stated that as per Medical Council of India norms, 1600 Sq.m space is required for the Library Building for a Medical College with an annual intake of 100 MBBS seats per year. The area of the existing Library Building in Government Vellore Medical College, Vellore is 1143. Sq.m.

3. The Director of Medical Education has therefore requested the Government to accord administrative and financial sanction for a sum of Rs.89.00 lakh in the schedule of rates for the year 2015-2016 for construction of additional Library Building with 457.80 Sq.m area (Ground floor - 362 Sq.m and first floor - 95.80 Sq.m) in Government Vellore Medical College, Vellore.

4. The Government, after careful examination, accept the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.89.00 lakh (Rupees eighty nine lakh only) in the schedule of rates for the year 2015-2016 for construction of additional Library Building in Government Vellore Medical College, Vellore.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-

“4210 - Capital Outlay on Medical and Public Health - 01 Urban Health Services – 110 - Hospitals and Dispensaries (including Pharmacy) - Schemes in the Twelfth Five Year Plan-II - State Plan – JA - Buildings 16- Major Works. (DPC 4210-01-110-JA-1602)”

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings) is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate 2016-2017/Revised Budget Estimate 2016-2017 to Finance Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.78/ADS(Dr.PU)/Health-II/2016, dated:04.03.2016 and 2564 (Two thousand five hundred and sixty four).
