### ORDER:

In the Government Orders 1<sup>st</sup> and 2<sup>nd</sup> read above orders have been issued among others for the fee payable by the Self Financing private Institutions for availing clinical training for their students. In the Government Order 3<sup>rd</sup> read above, the powers have been delegated to the Deans / Head of Institutions to grant permission to the students to do Project / Research work / Data collection / Observer ship, etc. and to the Medical / Dental graduates to undergo Junior Residentship in the clinical departments at Medical Colleges / Medical College Hospitals and it has been ordered to obtain permission of the Government for cases involving sensitive issues in the areas like Cancer Research, Aids, Mental Health and Drugs related diseases, and fees collected from the students to do Project / Research work / Special Training, etc., were revised.

- 2. In the Government Order 5<sup>th</sup> read above revised fee structure payable by the Self Financing Institutions for availing clinical tie-up for training their students in the Government Teaching Institutions / Institute of Mental Health were fixed.
- 3. In the reference 6<sup>th</sup> read above, the Director of Medical Education, has sent a comprehensive proposal for revision of fee structure for various training

programmes being conducted at the Government Medical College Hospitals / Government Hospitals / Primary Health Centre for the benefit of the students of Private Medical / Dental / Paramedical Institutions including institutions under Deemed Universities and has requested the Government to issue necessary orders in this regard.

- 4. The Government after careful examination, have decided to accept the request of the Director of Medical Education and direct that the existing fee for various training programmes being conducted at the Government Medical College Hospital / Government Hospital / Primary Health Centre for the benefit of the students of Private Medical / Dental / Paramedical Institutions including institutions under Deemed Universities be revised as indicated in the annexure to this order subject to the continuance of delegation of powers and other terms and conditions as laid down in the Government Orders 1<sup>st</sup> to 5<sup>th</sup> read above.
- 5. This order issues with the concurrence of Finance Department vide its U.O. No.60364 / Health-II / 2014, dated 18.11.2014.
