ORDER:

The Director of Medical Education in the letter read above, has sent the proposal for construction of Protection Wall and Entrance Arch to the Government Villupuram Medical College Hospital, Villupuram.

- 2. The Director of Medical Education has stated that the construction of Protection Wall to the Villupuram Medical College and Hospital, Villupuram has been completed in Eastern side and partly in North and South sides to a length of 1731 m. The estimate has been prepared for the construction of balance length of 820.50 m. The provisions like construction of Protection Wall for 820.50 m length, front elevation for ornamental entrance arch, name board sign board, fire fighting and name board special lighting arrangements, labour welfare fund, tender advertisement charges and unforeseen items have also been included in the estimate.
- 3. The Director of Medical Education has requested the Government to accord administrative and financial sanction for a sum of Rs.70.00 lakh for the year 2014-2015 and Rs.77.00 lakh in the schedule of rates for the year 2015-2016 for the construction of Protection Wall and Entrance Arch to the Government Villupuram Medical College Hospital, Villupuram. She has countersigned and forwarded the rough cost estimates prepared by the Superintending Engineer (Buildings), Public Works Department, Chennai.
- 4. The Government have examined the proposal of the Director of Medical Education and to accord administrative and financial sanction for a sum of Rs.77.00 lakh (Rupees Seventy Seven lakh only) in the schedule of rates for the year 2015-2016 towards construction of Protection Wall and Entrance Arch to the Government Villupuram Medical College Hospital, Villupuram.

- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-
 - "4210-Capital Outlay on Medical and Public Health-01 Urban Health Services 110 Hospitals and Dispensaries (Including Pharmacy) Schemes in the Twelfth Five Year Plan Il State Plan JA Buildings -16 Major Works" (DPC 4210-01-110-JA -1602)
- 6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of Legislature, the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the Contingency Fund will be issued by the Finance (BG-I) Department. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of the order to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2015-2016 to Finance Department at the appropriate time without fail.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.20458/Health-II/2015, dated 22.04.2015 and ASL No.134 (One Hundred and Thirty Four).
