#### ORDER:

In G.O.(Ms).No.183, Health and Family Welfare (EAP II-1) Department, dated: 30.06.2015, the Government issued orders permitting the Mission Director, State Health Society to execute the civil works for strengthening of the Maternal and Child Health (MCH) wings of Government Medical College Hospital, Tirunelveli and Trichy, at a total cost of Rs.4000.00 lakh (Rupees Four Thousand Lakh only) for both Medical College Hospitals.

2. As the bed strength has increased in Trichy and Tirunelveli Medical Colleges, the placement of additional Obstetricians and Gynaecologists, Anaesthetists, Paediatricians in the cadre of Assistant Professor and the Staff Nurses are necessary to give quality care to the patients. The proposed amount for the above Human Resources has been placed in Programme Implementation Plan 2017-2018 and has been approved in Record of Proceedings. The details are as follows:-

- 3. As per the National Health Mission norms, the above posts will be filled up on contract basis. As per the policy of the State Government, the Medical Officer post will be created in time scale of pay and the post of Staff Nurses will be created in 1:2 ratio (1 Regular post :2 Contract post)as per the orders issued in G.O.(MS). No 400, dated: 16.12.2014. Their pay will be drawn through treasury mode.
- 4. The contractual pay to the posts sanctioned in National Health Mission will be remitted into Government account. The placement of Staff Nurses post is as follows:-

- 6. The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly issue following orders:

The Director Medical Education is the cadre controlling authority to the above posts.

- ii. The Director of Medical Education is permitted to fill up the above posts of Medical Officer in the cadre of Assistant Professors and 13 posts of Staff Nurse in regular time scale of pay to the above said Reproductive Child Health (RCH) centres of Excellence in the Medical College Hospitals in Trichy and Tirunelveli.
- iii. The Mission Director, National Health Mission is permitted to place 27 posts of Staff Nurse (13 posts to Trichy Medical college and 14 posts to Tirunelveli) on contract basis—at the rate of Rs.7700/- per month with an annual increment of Rs.500/- every year till they are regularized. They will be paid from the funds approved under National Health Mission, State Health Society, Tamil Nadu.
- iv. The Mission Director, National Health Mission is directed to remit the salary component of the Medical Officer and Staff Nurses approved in Record of Proceedings 2017-2018 to Government Account, under the following Head of Account:-
