ORDER:

In the Government order third read above, adhoc rule was framed for the post of Assistant Medical Officer cum Assistant Professor in Government college of Yoga and Naturopathy with effect from 06.09.2002. In the Government letter first read above, the post of Assistant Medical Officer cum – Assistant Professor has been re-designated as Assistant Medical Officer / Assistant Lecturer with effect from 23.02.2004.
