#### ORDER:

In the circumstances reported by the Director of Medical Education, the Government accord sanction for further continuance of the one temporary post of Nursing Assistant Grade- II attached to Chengalpattu Medical College Hospital, Chengalpattu mentioned against S.No.2 in the table in para 1 above, for the period from 01.01.2010 upto 30.04.2011.
- 3. The Government also accord sanction for revival of both the temporary posts of Nursing Assistant Grade- II attached to Chengalpattu Medical College Hospital, Chengalpattu mentioned in para 1 above, with effect from the date of filling up of the posts.

The holder of the post of Nursing Assistant Grade-II is eligible to draw besides pay in the time scale of pay Rs.4800-10000+GP.1300/- Dearness Allowance, House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.
  - 5. The expenditure shall be debited to the following head of account:-
