2.The corresponding 40% of the State Share against the 60% of the Government of India release of **Rs.55,20,41,000/- (Rupees Fifty five crore twenty lakh and forty one thousand only)** works out to **Rs.36,80,27,333/- (Rupees Thirty six crore eighty lakh twenty seven thousand three hundred and thirty three only)** .

3.. The Mission Director has requested the Government to issue orders for releasing a sum of **Rs.36,80,27,333/- (Rupees Thirty six crore eighty lakh twenty seven thousand three hundred and thirty three only)** towards the release of State Share contribution of grants in aid to the State Health Society under Infrastructure Maintenance, Tamil Nadu for the year 2015-16 as mentioned above and to authorize the Mission Director, State Health Society, to draw a sum of **Rs.36,80,27,333/- (Rupees Thirty six crore eighty lakh twenty seven thousand three hundred and thirty three only)** under National Health Mission through Treasury mode and credit into State Health Society Account.

4.. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of **Rs.36,80,27,333/- (Rupees Thirty six crore eighty lakh twenty seven thousand three hundred and thirty three only)** towards the release of State Share contribution of 4th installment (2) of Grants-in-aid for implementation of Infrastructure Maintenance under Centrally Sponsored Scheme for the year 2015-16 to the State Health Society, Tamil Nadu.
