ORDER:

The Mission Director, State Health Society in his letter read above has stated that the 60% share of Grants in Aid has been transferred by Government of India to Tamil Nadu State Government towards Cost Adjustment sanction in receipt of Commodity Grant (Anti TB Drugs) Procurement during 2015-2016 for **Revised TB Control Programme**,

2. The corresponding 40% of the State Share against the 60% of the Government of India release of **Rs.6,18,84,502/- (Rupees Six crore Eighteen lakh eighty four thousand five hundred and two only)** works out to **Rs.4,12,56,334/- (Rupees Four crore twelve lakh fifty six thousand three hundred and thirty four only)**.

3. Since Government of India have supplied drugs to the tune of **Rs.6,18,84,502/-** as per its Cost Adjustment Sanction in respect of Commodity Grant (Anti TB Drugs) Procurement during 2015-16, the amount of State share will have to be drawn from State Budget.

4. The Mission Director, National Health Mission has requested the Government to release a sum of **Rs.4,12,56,334/- (Rupees Four crore twelve lakh fifty six thousand three hundred and thirty four only)** towards State Share against the Govt. of India Cost Adjustment sanction in respect of Commodity Grant (Anti TB

Drugs) Procurement during 2015-16 as mentioned above and to authorize the Mission Director, State Health Society Tamil Nadu, to draw a sum of **Rs.4,12,56,334/- (Rupees Four crore twelve lakh fifty six thousand three hundred and thirty four only)** under National Health Mission through Treasury mode.

5. The Government examined the proposal of Mission Director and has decided to accept it. Accordingly the Government release a sum of Rs. **4,12,56,334/- (Rupees Four crore twelve lakh fifty six thousand three hundred and thirty four only)** towards 40% of State Share against the Govt. of India Cost Adjustment sanction in respect of Commodity Grant (Anti TB Drugs) Procurement for the "Revised TB Control Programme' during 2015-16.
