ORDER:-

The Hon'ble Minister (Health and Family Welfare), has made the following announcement during the year 2017-2018, on the floor of Tamil Nadu Legislative Assembly:-

“Increase of 100 MBBS seats in two Medical Colleges at Tirunelveli Medical College and Madurai Government Medical College with initial budget provision of Rs.53.33 crore. “

2. The Government of India, Ministry of Health and Family Welfare has informed that under the Centrally Sponsored Scheme for 'Upgradation of existing State Government/ Central Government Medical College to increase MBBS seats in the country', the Government Medical Colleges at Coimbatore, Tirunelveli, Kanyakumari and Madurai in the State of Tamil Nadu have been approved for increasing 345 MBBS seats. The cost of the project will be shared between the Centre and the State in the ratio of 60:40 (revised) respectively with the upper ceiling cost pegged at Rs.1.20 crore per MBBS seat. The Government of India has released a sum of Rs.24.00 crore towards the Grant-in-aid for Tirunelveli Medical College, Tirunelveli.

3. The Director of Medical Education has sent necessary proposal for the construction of buildings at Tirunelveli Government Medical College, Tirunelveli along with rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Madurai region, in the schedule of rates for the year 2017-2018 against the Central Share and State Share for the purpose of increase of MBBS seats from 150 to 250 and has requested the Government to accord administrative and financial sanction for construction of the buildings for a sum of Rs.1884.75 lakh in the schedule of rates for the year 2017-2018 as detailed below:-

The Government, after careful examination of the proposal of the Director of Medical Education, accord administrative and financial sanction for construction of the following buildings in the Tirunelveli Government Medical College, Tirunelveli at a cost of Rs.1743.84 lakh (Rupees Seventeen crore forty three lakh and eighty four thousand only) under the scheme of upgradation of existing State Government / Central Government Medical Colleges in the country to increase MBBS seats with sharing pattern between Center and State in the ratio of 60:40 respectively.
