ORDER:

In the Government Order first read above, the Government have ordered to start three years post graduate course in three specialities viz., MD(Naturopathy), MD(Yoga) and MD (Accupuncture) with an intake of five students in each speciality, in the Government Yoga and Naturopathy Medical College, Chennai from the academic year 2014-2015.

- 2. Based on the request of the Commissioner of Indian Medicine and Homoeopathy second read above, the Government approve the Prospectus, Application Forms and Notification etc., for the Post Graduate course in MD (Yoga and Naturopathy) 2014 2015 conducted at Government Yoga and Naturopathy Medical College, Chennai annexed to this order with specific approval on the following:
 - i. The cost of application shall be fixed at Rs.2000/- (Rupees two thousand only)
 - ii. Applications can be issued to candidates through Tamil Nadu Health Department Website on par with allopathy side.
 - iii. The Entrance Examination will be conducted for 3 hours as in the case of MD(Siddha)

- iv. Candidates belonging to SC/SCA/ST community shall be exempted from paying the cost of application as per G.O.(Ms).No.111/ Adi-Dravidar and Tribal Welfare Department, dated 22.09.1998.
- v To follow the rule of reservation for filling up of the seats in Post Graduate MD (Yoga and Naturopathy) course for the academic year 2014-15 session duly adopting roaster method of reservation since each branch has only less than eight seats.
- vi. Minimum eligibility marks for admission is fixed as follows:

For O.C., B.C., B.C.(Muslim), M.B.C./D.C. candidates: 40%
For SC/SCA/ST candidates: 35%
For Service candidates(irrespective of all
Communities): 35%

- vii. The total marks for MD (Yoga and Naturopathy) Entrance Examination may be fixed as 100 (for Written: 90 marks + Experience: 10 marks)
- viii. The Commissioner of Indian Medicine and Homoeopathy shall be permitted to publish the MD (Yoga and Naturopathy) Entrance Examination 2014-15 session results.
- ix. Since the printing of MD (Yoga and Naturopathy) Entrance Examination Question papers should be in a confidential manner, printing works shall be entrusted to Confidential Press/ Tamil Nadu Dr.M.G.R. Medical University.
