ORDER:

In the Government Order second read above, an amendment orders have been issued to Government order first read above for creating four temporary post i.e. Assistant Surgeon (Dental), Staff Nurse, Dental Hygienist and Hospital Worker to the Government Hospital, Kadaladi, Ramanathapuram District under the control of the Director of Medical and Rural Health Services.

2. In the letters third read above, the Director of Medical and Rural Health Services has stated that the posts of Staff Nurse and Hospital Worker were filled on 04.01.2012 and 25.09.2009 respectively and their salary had been claimed upto 30.09.2013. The holders of the post were not claimed their salary from 01.10.2013.

3. The Director of Medical and Rural Health Services has requested the Government to accord sanction for revival and further continuance of one temporary post of Staff Nurse and one temporary post of Hospital Worker attached to Government Hospital, Kadaladi, Ramanathapuram District for the period from 01.10.2013 to 30.06.2016 and also requested for ratification for having claimed the pay bill by Joint Director of Health Services, Ramanathapuram to the above 2 posts for the period from the date of Joining to 30.09.2013.

4. The Government have examined the proposal in detail and decided to accept the proposal of the Director of Medical and Rural Health Services and accordingly ratify the action for having claimed the pay bill by Joint Director of Health Services, Ramanathapuram to the above 2 posts for the period from the date of Joining i.e. 04.01.2012 and 25.09.2009 respectively to 30.09.2013 and also revive the said post (i.e. Staff Nurse & Hospital Worker). The Government also accorded further continuance for the one post of Staff Nurse, in the Scale of Pay 9300-34800 + G.P.4450 and one post of Hospital Worker in the Scale of Pay 4800-10000 + G.P.1300 to Government Hospital, Kadaladi, Ramanathapuram District for the period from the date of Joining (i.e. 04.01.2012 and 25.09.2009) to 30.09.2015.

5. The expenditure towards Salary shall be debited to the following head of account:-
