The Mission Director, State Health Society in his letter read above as stated that the 60% share of Grants in Aid has been released by Government of India to the State for National Vector Borne Disease Control Programme for the year 2015-16 under National Health Mission.

The corresponding 40% of the State Share against the 60% of the Government of India release of Rs.3,22,75,000/- (Rupees Three crore twenty two lakh and seventy five thousand only) works out to Rs.2,15,16,667/- (Rupees Two Crore fifteen lakh sixteen thousand six hundred and sixty seven only)..Since Government of India has transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, and the amount of Central Share and State share will have to be drawn from State Budget.

3. The Mission Director i/c has requested the Government to issue orders for the release of a sum of Rs.5,37,91,667/- (Rupees Five crore thirty seven lakh ninety one thousand six hundred and sixty seven only) Release of Grants-in-aid for National Vector Borne Disease Control Programme during the year 2015-16 as mentioned above and to authorize the Mission Director, State Health Society Tamil Nadu, to draw a sum of Rs.5,37,91,667/- (Rupees Five crore thirty seven lakh ninety one thousand six hundred and sixty seven only) under National Health Mission through Treasury mode.

The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of **Rs. 5,37,91,667/-** (Rupees Five crore thirty seven lakh ninety one thousand six hundred and sixty seven only) towards Grants-in-aid for National Vector Borne Disease Control Programme during the year 2015-16 to the State Health Society, Tamil Nadu.
