ORDER:

In the reference first read above, an amendment to rule 7 of the Adhoc rules governing the post of Assistant Medical Officer (Unani) has been issued with an intention to dereserve the unfilled vacancies under the communal reservation in the event of no suitable candidate is available in the respective communal categories so as to fill up the vacancies from any other categories on merit.

- 2. In the reference second read above, an amendment to rule 7 of the adhoc rules have been issued.

In the reference third read above, the Secretary, Tamil Nadu Public Service Commission has requested that the validating provision issued in the notification No. 48/2012, dated 16.11.2012, pertaining to the post of AMO (Unani), the amendment has to take retrospective effect (i.e) from 16.11.2012.

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Health

and Family Planning Department Notification No.SROB-24/2015, published at page - 38 of Part III-Section 1(b) of the <u>Tamil Nadu Government Gazette</u>, dated the 1st April 2015.

2. The amendment hereby made shall be deemed to have come into force with effect from 1st April 2015.

In the said Notification, in the preamble, after the existing paragraph, the following paragraph shall be added, namely:-

"2. The amendment hereby made shall be deemed to have come into force with effect from the 16th November 2012".
