ORDER:

In the letter read above the Director of Medical Education has stated that the Dean, Madras Medical College, Chennai has stated that the new Madras Medical College is functioning in the Old Jail Campus since 2013 and first year Under Graduate Medical Courses are being conducted in the new building. All the facilities have been provided to the newly constructed buildings except water and sewerage connection which has to made by the Chennai Metropolitan Water Supply and Sewerage Board (CMWSSB) and Chennai Metropolitan Water Supply and Sewerage Board has been requested to take immediate action to provide water and sewerage connections to the newly constructed building in the old jail campus and the Chennai Metropolitan Water Supply and Sewerage Board has informed that an amount of Rs.13,11,819/- is pending to be paid for the period from May 2001 to October 2003 by the previous occupier, the Superintendent, Chennai Central Prison and has sent a demand notice for the said amount for making provision or water and sewerage connections to the Old Jail Campus. Hence, the Dean, Madras Medical College, Chennai has requested sanction for an amount of Rs.13,11,819/- (Rupees thirteen lakhs eleven thousand eight hundred and nineteen only) to pay the pending amount to the Chennai Metropolitan Water Supply and Sewerage Board.

- 2. In this connection, the Director of Medical Education has requested to issue necessary sanction order for Rs.13,11,819/-. (Rupees thirteen lakhs eleven thousand eight hundred and nineteen only) to enable the Dean, Madras Medical College, Chennai to pay the pending amount to Chennai Metropolitan Water Supply and Sewerage Board.
- 3. The Government examined the request of the Director of Medical Education in detail and accord sanction for a sum of Rs.13,11,819/- (Rupees

Thirteen lakhs eleven thousand eight hundred and nineteen only) towards payment of pending bills to the Chennai Metropolitan Water Supply and Sewerage Board for the water and sewerage charges in respect of New Madras Medical College Building at Old Central Jail Campus for the period from May 2001 to October 2003, as a special case, so as to enable the Chennai Metropolitan Water Supply and Sewerage Board to provide water and sewage facilities for the above building.

- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-
 - "2210 Medical and Public Health 05 Medical Education Training and Research 105 Allopathy I Non Plan AA Chennai Medical College 06 Rent, Rates and Taxes 03 Water Charges (DPC 2210-05-105-AA-0630.)"
- 5. Necessary funds will be provided in the Revised Estimate/Final Modified Appropriation 2014-15 pending provision of funds in Revised Estimate/Final Modified Appropriation 2014-2015, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 1 above. The Director of Medical Education is requested to include this expenditure while sending the budget proposals for Revised Estimate/Final Modified Appropriation 2014-15 to Government in Finance Health-II Department without fail.
- 6. This order issues with the concurrence of the Finance Department vide its U.O. No.62543/Health–II/2014, dated: 08.12.2014 and ASL No.1691 (One thousand six hundred and ninety one).
