ORDER:

The adhoc rule for the post of Health Education Extension Officers was issued in the Government Order first read above. Consequent on the transfer of the post of Health Education Extension Officer in Regional Family Planning Training centre from the Directorate of Health Services and Family Planning to the Directorate of Public Health and Preventive Medicine and based on the advice of the Tamil Nadu Public Service Commission a suitable amendment is necessary to issue in respect of the post of Health Education Extension Officer.

2. The amendment hereby made shall be deemed to have come into force on the 01.04.1989.

AMENDMENT

In the said Rules, in rule 1, for the expression "Regional Family Planning Training Centres at Salem and Egmore", the expression "Health and Family Welfare Training Centres under the control of the Public Health and Preventive Medicine Department" shall be substituted.
