### **ORDER:-**

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy, has stated that the Principal, Government Siddha Medical College, Chennai has stated that the Government Siddha Medical College, Chennai was started in the year 1985 and Rs.2,000/- was given as the Permanent Advance from the starting of college. The permanent advance of Rs.2,000/- is not adequate to meet out day to day contingent expenditure arising at the college such as transportation charges, court expenditure, flag hoisting and for office maintenance, etc. and he has requested to enhance the Permanent Advance from Rs.2,000/- to Rs.10,000/- to meet out day to day contingent expenditure and petty expenditure arising at Government Siddha Medical College, Chennai for smooth functioning of that College and Hospital.

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has justified that it is most essential to raise the Permanent Advance amount to maintain the institution and therefore requested the Government to enhance the Permanent Advance from Rs.2,000/- to Rs.10,000/- (Rupees Ten thousand only) for Government Siddha Medical College, Chennai to meet out day to day expenditure.
