ORDER:

During the Assembly Session 2021 – 2022, the Hon'ble Minister for Health and Family Welfare has made the following announcements in the Floor of the Tamil Nadu Legislative Assembly (Announcement No.7):-

Announcement No.37

2. The Mission Director, National Health Mission in his letter read above has stated that, National Health Mission has strengthening the Maternal Child Health wings and CEmONC Centres in Tertiary Care Institutions, District Hospitals and sub-district Hospitals in the State in order to provide State - of - the - art and to cope with the increased demand for Maternal Child Health services. Further, he has stated that, an analysis of the maternal and infant mortality data reveal that 75% of maternal deaths occur during intra partum and postpartum and 25% occur in ante partum. In order to provide Quality maternal care as per IPHS guidelines, it is recommended to strengthen the Maternal Child Health wing in the Government Hospitals and to upgrade them to 'High Dependency Units'. Besides, critical care management will be improved, which in turn will reduce the referral outs and improve the Quality of Antenatal and Postnatal care provided so as to decrease new born and maternal mortality. Considering the necessity and based on gap analysis done, a detailed proposal for provide additional buildings for strengthening of Maternal

Child Health wings in the 6 Government Hospitals in the State, which have high bed occupancy rate was included in PIP 2021-22 as detailed below:-

The balance of funds required for the civil works are to be proposed in the subsequent PIPs.

4. As per the directions issued in G.O.(Ms)No.116, Health and Family Welfare department, dated:25.3.2011, the Mission Director, National Health Mission has issued sanction orders for the drawal and remittance of a sum of Rs. 1240.20 lakh, approved for the year 2021-22 for construction of new Maternal Child Health Wing Buildings in the 5 Sub District Hospital / 1 District Head Quarters Hospital and remitted the same to Government, vide challan No.396 dated 25.10.2021 and Challan No.426, dated:03.01.2022 of SBI Treasury Branch Chennai, approved for the year 2021-22, for the construction of above said buildings. He has also stated that, the 41st Executive Committee of National Health Mission, Tamil Nadu has approved the above proposal on 17.06.2021 and requested the Government to issue necessary orders in this regard.

5. The Government after careful examination have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly do and hereby issue orders on the following:-

- i. The Mission Director, State Health Society is permitted to construct 100 bedded Maternal Child Health buildings to Sub District Hospitals at Gobichettipalayam, Thindivanam, Tambaram, Srivilliputhur, Ambasamuthiram and District Head Quarters Hospital at Tenkasi at a total cost of Rs.4134.00 lakh (Rupees Forty one Crores Thirty four lakhs only) at the rate of Rs.689.00 lakh (Rupees Six Crores eighty nine lakhs only) per Hospital, subject to the condition that, all important support services like ETP, Fire safety, MGPS, water supply and sanitation etc. shall be part of this & Layout plan and service flow will be as per the guideline of the Government of India.
- ii. Administrative sanction is accorded to execute the civil and electrical works for construction of 100 bedded Maternal Child Health buildings to the Sub District Hospitals/District Head Quarters Hospitals at a total cost of Rs.4134.00 lakh (Rupees Forty one Crores Thirty four lakhs only) through Public Works Department as detailed below:-

- iii. Financial sanction is accorded for a sum of Rs.1240.20 lakh (Rupees Twelve Crores forty lakhs and twenty thousand only) to execute the civil and electrical works for construction of 100 bedded Maternal Child Health buildings to the Sub District Hospitals/District Head Quarters Hospitals at Tindivanam, Tambaram, Srivilliputhur, Gobichetipallyam, Ambasamudram, Tenkasi.
- iv. The Engineer in Chief and Chief Engineer buildings PWD, Chepauk, Chennai is directed to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds under the head of account "4211 00 103 AA 1606", for executing the civil and electrical works.
- v. The Mission Director, National Health Mission is permitted to remit the balance of funds required in this regard as and when the funds are approved by Government of India.
