ORDER:

In Government Order first read above, the Government sanctioned a sum of Rs. 3.02 Crores for construction of building for Regional Cancer Centre in Government Rajaji Hospital, Madurai. In the reference second read above, the Director of Medical Education has reported that the estimate for the construction of building for Regional Cancer Centre in Government Rajaji Hospital, Madurai has been priced at the current schedule of rates and has been worked out of as Rs. 3.80 Crores and the reason for the excess is due to additional quality of work involved for the modified plans, enhanced provisions in electrical items approved by AERB, Mumbai and also due to escalation during the interim period from the date of administrative approval to the date of approval of plans by AERB, Mumbai.

2. Therefore, the Director of Medical Education has sent a proposal and requested the Government to sanction an additional amount of Rs.78.00 Lakhs (Rupees Seventy Eight Lakhs Only) for the construction of Regional Cancer Centre in Government Rajaji Hospital, Madurai.

3. The Government, after careful examination, have decided to accept the proposal of the Director of Medical Education, and to accord revised administrative and financial sanction for a sum of Rs.380.00 lakhs (Rupees Three Hundred and Eighty Lakhs only) for the construction of Regional Cancer Centre of Government Rajaji Hospital, Madurai as against the original sanctioned amount of Rs.302.00 lakhs due to additional quality of work involved for the modified plans, enhanced provision in electrical items approved by the AERB, Mumbai.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account.

" 4210 – Capital Outlay on Medical on Public Health – 01-Urban Health Services – 110 – Hospitals and Dispensaries (including Pharmacy) – Schemes in the Twelfth Five Year Plan II - State Plan – JA. Buildings – 16 Major Works".(DPC - 4210-01-110-JA-1602)

5. The Additional expenditure due to Revised Administrative sanction Sanctioned in para 3 above shall constitute an item of " New Instrument of Service and the approval of legislature will be obtained in due course. Pending approval of Legislature the expenditure will be initially met by an advance from the contingency fund. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department. The Chief Engineer (Building) Chennai shall apply for sanction of advance from contingency fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Chief Engineers (Building) Chennai shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-'15 to Finance Department at the appropriate time without fail.
