From the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy Letter No.3289/IM2-1/12, dated 30.12.2014 and 18.05.2015.

ORDER:

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that the Principal, Government Unani Medical College, Chennai has informed that the Department of AYUSH, Government of India in their L.No.R.11011/09/2013 EP(IM.I) Pt. dated 25.9.2014 have reiterated that as per the provisions in the Regulation 3 of the Minimum Standard Requirement (MSR) for Ayurveda, Siddha, Unani (ASU) Colleges, all Colleges have to fulfill all the MSR of infrastructure, teaching and training facilities as specified by 31.12.2014 to get permission for a period not exceeding five years failing which permission shall be denied from academic year 2015-16 and action shall be initiated under section 21 of the Act for non compliance of Minimum Standard Requirement. As per Central Council of Indian Medicine norms there is shortfall of 2 cadre i.e., two Lecturer posts, one in the Department of Niswan Wa Qabalat (Gynaecology and Obstetrics) and another in Amraze Jiid Wa Tazeeniyat (Skin and Cosmetology) Department.

2. The Additional Chief Secretary / Commissioner of Indian Medicine and Homoeopathy has, therefore, requested the Government to create two posts of Lecturer in the Government Unani Medical College, Chennai since the necessity of creation of post is very urgent and to be filled up in this year itself to fulfill the norms of Central Council of Indian Medicine.

3. The Government have examined the proposal of the Additional Chief Secretary / Commissioner of Indian Medicine and Homoeopathy and accord sanction for creation of two posts of Lecturer in Niswan Wa Qabalat (Gynaecology & Obstetrics) and Amraze Jiid Wa Tazeeniyat (Skin and Cosmetology) with the scale of pay of Rs. 15600-39100+ GP 6600 to the Government Unani Medical College, Chennai.

4. The expenditure required for the posts created in para 3 above shall be debited to the following Head of Account:-
