ORDER:

In G.O. (Ms.) No.174, Health and Family Welfare Department, Dated: 07.09.2006, accorded permission to the Chairman, "Vel Institute of Science and Technology Trust" Chennai to start the College of Nursing in the name and style as "Venkateswara Nursing College" to conduct B.Sc (Nursing) course with an annual intake of 50 students from the academic year 2006-2007.

2. The Principal, Venkateswara Nursing College, Thalambur, Chennai has requested to issue necessary orders for enhancement of B.Sc (Nursing) Course from 50 to 60 seats from the academic year 2019-2020.

- 3. Based on the request, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Nursing College has fulfilled the conditions prescribed by the Government and the Indian Nursing Council, New Delhi for increase of B.Sc (Nursing) Course from 50 to 60 seats. The Director of Medical Education has submitted proposal along with the inspection report / Project Report along with his specific remarks to the Government and requested to issue necessary orders.
- 4. The Government have examined the case in detail in the light of the recommendation of the Inspection team and the Director of Medical Education and permit the Principal, Venkateswara Nursing College, Thalambur, Chennai, to apply to the Indian Nursing Council, New Delhi run by Vel Institute of Science and Technology Trust, Chennai for increase of B.Sc (Nursing) Course from 50 to 60 seats at Venkateswara Nursing College, Thalambur, Chennai from the academic year 2019 2020, subject to the following conditions:-
 - (a) Admission of students shall be made as per the rules fixed by the Government from time to time.
 - (b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.
 - (c) The Trust should obtain recognition/ suitability from the Tamil Nadu Nurses and Midwives Council, Chennai and Indian Nursing Council, New Delhi respectively before admitting the students for increase of seats from 50 to 60 in B.Sc (Nursing) Course.
 - (d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non-compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc.
 - (e) The Trust should fulfill the Teacher student ratio as per the norms of Indian Nursing Council, New Delhi.
 - (f) The Trust should obtain the building completion certificate from the competent authority for the proposed Nursing College and submit to the Government before admitting the students.

5. The Director of Medical Education is requested to take necessary further action accordingly.
