ORDER:-

In the Government order first read above, orders have been issued to sanction a sum of Rs.2.21 crore for the construction of Radiation Oncology Block in Government Royapettah Hospital, Chennai. In Government order second read above, orders have been issued to grant permission to the Director of Medical Education to procure two Linear Accelerator (LINAC) by pooling the fund of Rs.31.00 crore already sanctioned by the State Government for procurement of four Linear Accelerators (LINAC) and CT Simulators to Coimbatore, Madurai, Thanjavur and Tirunelveli hospital in various Government orders and to install the above two Linear Accelerators (LINAC) at Rajiv Gandhi Government General Hospital, Chennai and Government Royapettah Hospital, Chennai.

- 2. In his letter third read above, the Director of Medical Education has stated that the building for Radiation Oncology Block in Government Royapettah Hospital, Chennai is ready and patient load is more in this institution. Hence, the Director of Medical Education has requested the Government to create 15 additional posts in various categories for the functioning of the Dual Energy Linear Accelerator in the Institute of Oncology at Government Royapettah Hospital, Chennai.
- 3. The Government, after careful examination of the proposal of Director of Medical Education in detail, accord sanction for creation of the following 15 additional posts for the functioning of the Dual Energy Linear Accelerator in the Institute of Oncology at Government Royapettah Hospital, Chennai with an annual average recurring cost of Rs.1,32,51,252/- (Rupees One crore thirty two lakhs fifty one thousand two hundred and fifty two only):-

- 4. The expenditure towards pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-
 - "2210. Medical and Public Health 01. Urban Health Services Allopathy 110. Hospital and Dispensaries State's Expenditure AN. Government Royapettah Hospital, Chennai 01. Salaries. (DPC 2210 01 110 AN 0100)".
 - ii) 33 payment for professional and special services 04 contract payment (DPC 2210 01 110 AN 3349)
- 5. The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from

Finance (BG-I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018-2019 to Finance (BG-I/Health-II) Department at the appropriate time without fail.
