ORDER :

The Director of Medical Education in his letter read above has stated that the Psychiatric Building is functioning in the South side of Government Hospital Campus of Government Mohan Kumaramangalam Medical College Hospital, Salem. The existing building was constructed with ground floor and first floor in West side and only with ground floor in East side. As per the Medical Council of India norms, the existing building is not sufficient to accommodate the patients. Hence, the Dean, Government Mohan Kumaramangalam Medical College Hospital, Salem and the Head of the Department (Psychiatric) has sent the proposal for the construction of Faculty Room, Library cum Seminar Hall and Ward in the existing Psychiatric Building in Government Mohan Kumaramangalam Medical College Hospital at Salem.

2. The Director of Medical Education has stated that the Dean, Government Mohan Kumaramangalam Medical College Hospital, Salem has furnished the necessary justification and the details of the Inspection conducted by the Medical Council of India authorities and shortfalls / deficiencies for the construction of Faculty Room, Library cum Seminar Hall and Ward in the existing Psychiatric Building.

3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by the Chief Engineer (Buildings), Public Works Department, Trichy Region, Tiruchirappalli and requested the Government to accord administrative and financial sanction for the construction of Faculty Room, Library cum Seminar Hall and Ward in the existing Psychiatric Building in Government Mohan Kumaramangalam Medical College Hospital, Salem at an estimated cost of Rs.72.50 Lakh for the year 2016-2017, by adding 10% escalation cost on the scheduled rates, amounting to Rs.79.75 lakh for the year 2017-2018.

4. The Government, after careful examination of the proposal of the Director of Medical Education, accord administrative and financial sanction for a sum of Rs.74,63,000/- (Rupees Seventy four lakh and sixty three thousand only) towards construction of Faculty Room, Library cum Seminar Hall and Ward in existing Psychiatric Building in Government Mohan Kumaramangalam Medical College Hospital, Salem.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account (Demand No.39 02):-

“4210. Capital Outlay on Medical and Public Health – 01. Urban Health Services – 110. Hospitals and Dispensaries (including Pharmacy) - State's Expenditure – JA. Buildings – 16. Major Works.
(DPC 4210 – 01 – 110 – JA - 1602)”

6. The expenditure sanctioned in para 4 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimates for the year 2018-2019 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department, directly in Form A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from Contingency fund will be issued from to Finance (BG-I) Department, for sanctioning the advance for required quantum. The Chief Engineer (Buildings) is also directed to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2018-2019 to Finance (BG-I) Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department, vide its U.O. No.17499/Health-II/2018, dated 17.04.2018 and ASL No.40 (Forty).


