ORDER:

The Director of Medical Education and Research in the letter read above has stated that there were 143, 154 and 268 Non Service Post Graduates (Higher Speciality) who completed their PG courses in the years 2020, 2021 and 2022 respectively. By conducting the online counseling, they were accommodated in the regular vacancies under Directorate of Medical Education and Directorate of Medical and Rural Health Services. Due to the reasons such as the candidates having not participate in the counseling earlier or no vacancies in the concerned specialities, etc., 198 candidates (Non Service post graduates) from the year 2020, 2021 and 2022 have to be accommodated to complete their bond service as detailed below:-

2. The Director of Medical Education and Research has further stated that, there are no adequate vacancies to accommodate the above Non Service Post Graduates (Higher Speciality) in the regular vacancies and hence requested the Government to issue necessary instruction for retention or return of original certificates to the Non Service Post Graduates (Higher Speciality).

3. The Government have examined the issue in detail in the light of the orders of the Hon'ble High Court of Madras in various Writ Petitions in the matter and have proposed to accept the request of the Director of Medical Education and Research and to return the original certificates to the Non Service Post Graduate candidates who have completed the bond period but not the bond service due to want of adequate vacancies; and to the Non Service Post Graduate candidates who have not completed their bond period subject to the following conditions:-

- That the Students taking back their Original Certificates to pursue higher studies, must inform the authorities their present permanent address duly and if there is any change of address it shall also be reported then and there to the Medical College and the Director of Public Health and Preventive Medicine;
- That the Students on completion of their higher studies must report to the Director of Public Health and Preventive Medicine for getting posting as per the bond condition;
- That in case, the Student doesn't join after getting admission or discontinuing the higher studies, he / she must report to the Director of Public Health and Preventive Medicine for completing the bond obligation / posting.
- The Director of Medical Education and Research is directed to release the original certificates (whatever submitted) to the respective students after obtaining undertaking in Rs. 100/- Stamp Paper to be executed by the students, their parents and with two security witnesses incorporating the above conditions, along with other general conditions.
- The Director of Public Health and Preventive Medicine is also directed to maintain a list / register of the Students of State Medical Colleges to monitor such cases and arrange to initiate action "Suo Motu" to post the Students after three years period, in the Medical Institutions to complete their bond obligation services, even if the Student doesn't report to have posting.
