ORDER:-

The Director of Medical and Rural Health Services in his letter ninth read above, has stated that the period of further continuance in respect of temporary posts attached to the Government Non-Teaching Medical Institutions under the control of Directorate of Medical and Rural Health Services sanctioned by the Government had lapsed on 30.09.2015. The Director of Medical and Rural Health Services has also stated that the posts which are continued in the Government Orders cited are coming under essential service and the services of the incumbents

of the posts are quite essential to run the concerned Government Non-Teaching Medical Institutions.

- 2. The Director of Medical and Rural Health Services has requested the Government to accord sanction for further continuance of various temporary posts (as per annexure) attached to Government Non-Teaching Medical Institutions, under his control for the period from 01.10.2015 to 30.06.2018.
 - 3. The Government have carefully examined the proposal of the Director of Medical and Rural Health Services and accord sanction for the further continuance of 42 temporary posts mentioned in the Annexure-A to this order for the period from 01.10.2015 to 31.12.2016 or till the need there for ceases, whichever is earlier.
 - 4. The holders of the posts are eligible to draw besides pay in the time-scale of pay mentioned in the Annexure 'A' to this order, Dearness Allowance, House Rent Allowances and other allowances admissible under the rules in force and orders issued from time to time.
 - 5. The expenditure shall be debited to the Head of Account mentioned in the Annexure 'B' to this order for each district.
 - 6. This order issues with the concurrence of the Finance Department vide its U.O.No.57701/H-II/2015, dated 11.11.2015.
