ORDER:

The Director of Public Health and Preventive Medicine, in his letter read above has stated that the Tamil Nadu is one of the best performing States in terms of implementing Reproductive and Child Health Schemes and has already achieved the National Rural Health Mission / Reproductive Child Health goals. About one fourth of the deliveries across the state are happening in the Primary Health Centres. It is very essential to maintain knowledge management through various Maternal and Child Health trainings to improve the skills of the staff who are providing round the clock The Primary Health Care System is facing challenge due to frequent transfers, promotions as well as various factors like inter departmental transfer of Medical Officers and Staff Nurses. This results in attrition of the trained manpower and compromise the quality of services provided in all aspects. To sustain a continuous quality of care in Maternal and Child Health services, it is essential to ensure highly skilled ANMs are to be posted in Upgraded Primary Health Centres initially. Therefore, a proposal for imparting training to VHN / ANM to strengthen the midwifery services was proposed in the PIP 2014-15 and the Government of India have approved the proposal for one year in-service training to Village Health Nurse / Auxiliary Nurse Midwife to strengthen midwifery services, who have completed minimum five years of service in the Director of Public Health and Preventive Medicine, in ROP 2014-2015. The above training programme has been approved for Rs.201.02 lakh for 10 batches at Rs.20,10,200/- per batch.

2. The Director of Public Health and Preventive Medicine has requested the Government orders to commence the above training for 200 Village Health Nurses / Auxiliary Nurse Midwives with a batch size of 20 participants each which is detailed in the annexure to this Government Order.

- 3. The Government after the detailed examination, have decided to accept the request of the Director of Public Health and Preventive Medicine and they accordingly permit the Director of Public Health and Preventive Medicine to commence the one year in-services training programme to 200 VHNs / ANMs to strengthen midwifery services at the cost of Rs.201.02 lakh for 10 batches at Rs.20,10,200/- (Rupees Twenty lakh ten thousand and two hundred only) per batch of 20 participants. The entire expenditure will be met from the National Rural Health Mission funds approved in the PIP 2014-15 and released by the Mission Director, State Health Society, Chennai-6.

<u>Details of the training Programme to VHN / ANM to strengthen the Midwifery Services</u>

Eligibility criteria for selection:

Minimum 5 years experience as Village Health Nurse / Auxiliary Nurse Midwife in the Public Health Department and 10 years of left over service on the date of commencement of the training.

Method of selection and place of posting:

The willing VHNs / ANMs from the Primary Health Centres will be selected and given one year intensive training in midwifery and newborn care skills. They will be posted in Upgraded Primary Health Centres.
