### ORDER:

In his letters read above, the Director of Medical Education has stated that the Paediatric Neurology is a fast growing specialty and nearly 10% of the children attending paediatric Out Patient Department (OPD) and 25% of children in Paediatric Intensive Care Unit (ICU) have neurological problems. The number of Paediatric neurologists available are far less when compared to general neurologists. In view of the wide gap between the increasing number of the children with neurological problems and paediatric neurologists, who are a few in number compared to the real need, there is a definite need for a separate Super Speciality Department of Paediatric Neurology in Stanley Medical College Hospital, which is one of the pioneer Medical Colleges in India. The benefit of the poorest of the poor children with neurological problems, who cannot afford to get specialized care in the private sector, an initiative to be made to start D.M. Paediatric Neurology Course and post doctoral fellowship course in Paediatric Neurology in Stanley Medical College is absolutely essential. In order to make an initiative to start D.M. Paediatric Neurology course, the first of its kind in Government sector in South India and to start post doctoral fellowship course in Paediatric Neurology, establishment of a separate department is necessary.

2. The Director of Medical Education has, therefore, requested the Government to create a Department of Paediatric Neurology with 20 beds exclusively for Paediatric Neurology care at Stanley Medical College Hospital, Chennai and to create 9 posts in various categories for the Department of Paediatric Neurology, Government Stanley Medical College, Chennai and also requested to accord sanction for a sum of Rs.3,83,000/- towards purchase of furniture etc.,

3. The Government, after careful examination of the proposal of Director of Medical Education in detail and accord sanction for establishment of a Department of Paediatric Neurology with 20 beds exclusively for Paediatric Neurology care at Government Stanley Medical College Chennai, along with creation of following nine posts with an annual average recurring cost of Rs.1,01,18,052/- (Rupees One crore one lakh eighteen thousand and fifty two only) and also sanction for a

sum of Rs.3,83,000/- (Rupees three lakh eight three thousand only) towards purchase of furniture to the above newly established department.

4. The expenditure towards pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-

“2210. Medical and Public Health – 05. Medical Education, Training and Research – 105. Allopathy State’s Expenditure – AB. Stanley Medical College, Chennai – 01.salaries. (DPC 2210-05-105-AB-0101)”.

The expenditure towards purchase of furniture i.e. Rs.3,83,000/- sanctioned in para 3 above shall be debited to the following head of account:-

“2210. Medical and Public Health – 05. Medical Education, Training and Research – 105. Allopathy State’s Expenditure – AB. Stanley Medical College, Chennai – 05. Office Expenses 05 Furniture (DPC 2210-05-105-AB-0558)”.

5. The expenditure sanctioned in para - 3 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by

drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2018-2019 to Finance (BG-I) Department at the appropriate time without fail.

6. This order issues with the concurrence of the Finance Department vide its C.No.18692/Health-II/ dated: 19.04.2018 and U.O.No.21169/CMPC/2018, dated: 20.04.2018 and ASL No.107 (one hundred and seven).
