ORDER:

In the letter first read above, the Convenor, Federation and President of Tamil Nadu Government Doctors Association (TNGDA) has stated that the Madurai Rajaji Hospital Doctors and Staff (MADRADS) Co-operative Society Canteen limited may be permitted to run the canteen on the lines of the canteen run at the Secretariat and opened by the Hon'ble former Chief Minister.

2. The Director of Medical Education in her letter third read above has stated that the Dean, Madurai Medical College, Madurai has stated that in the College council meeting held on 04.05.2015 it has been unanimously decided as follows:-

- 1) *To run the canteen directed by the Madurai Rajaji Hospital Doctors and Staff Co-operative Society Canteen which is already registered with No.MM.3272 on the lines of that in Secretariat.*
- 2) *At building 90 Ground floor till permanent building is constructed as decided by the Public Works Department already.*

- 3) *Only Doctors, staff and students will be entertained there.*
- 4) *It will not be sub-lent or given contract to 3rd person.*

3. The Director of Medical Education has requested the Government to grant permission to run the Madurai Rajaji Hospital Doctor's and Staff Co-operative Society Canteen Limited in premises of Madurai Rajaji Hospital, Madurai.

The Government after careful examination of the proposal of the Director of Medical Education, grant permission to the Madurai Rajaji Hospital Doctor's and Staff Co-operative Society Canteen Limited, Madurai to run a canteen in Government Rajaji Hospital, Madurai in relaxation of the guidelines issued in the Government Order second read above, subject to the usual terms and conditions and other norms laid down, by the Medical Council of India.
