**ORDER:**

The Hon'ble Minister (Health and Family welfare) among others has made an announcement on the floor of Tamil Nadu State Legislative Assembly on 04.07.2017 that State Project Management Unit (SPMU) will be established under National Health Mission for monitoring the implementation of Comprehensive Primary Health Care Programmes at a cost of Rs.43.00 lakh and State Health Accounts Wing will be established at a cost of Rs.7.00 lakh (Total 50.00 lakh).

2. In Government order first read above, orders were issued to launch the pilot project on Comprehensive Primary Health Care Services in three Health Unit Districts (HUD) namely Krishnagiri – Shoolagiri Block, Pudukottai – Viralimalai Block and Perambalur – Veppur Block and permission was also accorded to utilize a sum of Rs.599.07 lakh (recurring and non-recurring) for the project. Subsequently, in Government order second read above, orders were issued for upscaling the above programme in the balance 39 Health Unit Districts (HUD) under National Health Mission at a total cost of Rs.4417.84 lakh.

3. In the letter third read above, the Mission Director, State Health Society has stated that to monitor the Comprehensive Primary Health Care Services / Universal Health Care in 42 Health Unit Districts in State, a proposal for Establishment of State Programme Management Unit (SPMU) for Universal Health Care and Maternal Child Health wing at the office of Director of Public Health and Preventive Medicine, Chennai was placed in the Programme Implementation Plan 2017-18 and the same was approved in Record of Proceedings 2017-18.

4. The Mission Director has informed that as per National Health Mission Guidelines, all posts should be on contract basis. However, the post of Additional Directors, Medical Officers, Maternal and Child Health Officer and other Para Medical Staff / Clerical Staff shall be filled up on regular time scale of pay as per the State Government Policy and pay and allowances to the incumbents shall be drawn through the Treasury. The consolidated amount / contractual pay to staff budgeted under National Health Mission, will be remitted into the Treasury, for the staff in position, based on the details of staff position from the District Health Societies. Therefore the staff cost is indicated as per existing National Health Mission norms.

5. The Mission Director, State Health Society has also stated that the above proposal was placed in the 33<sup>rd</sup> Executive Committee meeting of State Health Society vide Agenda No.45 and the same was approved.

6. The Mission Director, State Health Society has therefore requested Government orders in this regard.

7. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:-

- i) The Mission Director, State Health Society is permitted to establish State Programme Management Unit (SPMU) for Universal Health Care and Maternal Child Health wing at the office of Director of Public Health and Preventive Medicine, Chennai under National Health Mission.
- ii) Sanction is accorded to create the following posts under the cadre control of Director of Public Health and Preventive Medicine for establishment of above State Programme Management Unit (SPMU) and to fill up the posts as per the rules in force :-

- iii) The Mission Director, State Health Society is permitted to place the following posts through outsourcing agency with the consolidated pay as per the rules as detailed below:-

- iv) the posts mentioned in para 7(ii) & (iii) be created initially temporarily for a period of one year and the posts be continued based on the need and approval of National Programme Coordination Committee (NPCC) in the subsequent Programme Implementation Plans.

- v) the Mission Director, State Health Society is permitted to remit the salary component for the posts sanctioned in para 7(ii) into State Government account as when its approved by Government of India under the following Head of Account:-

8. The expenditure towards the salary cost of posts sanctioned in para 7(ii) shall be debited to the following new Head of Account:-

9. The Director of Public Health and Preventive Medicine is the Estimating Reconciling and controlling authority for the above new Head of Account. The Pay and Account Officer / Treasury Officers concerned are directed to open the above new Head of account in their books

10. The expenditure towards the staff cost of posts sanctioned in para 7 (ii) above is an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Public Health and Preventive Medicine is directed to apply for sanction of advance from the Contingency Fund to Finance (BG.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. The Director of Public Health and Preventive Medicine is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2018-2019 to Finance (BG.I/Health-I) Department without fail.
