ORDER:-

In the circumstances reported by the Director of Medical Education in her letter third read above, the Government accord sanction for further continuance of one temporary post of Steno Typist Grade-II attached to Government Arignar Anna Memorial Cancer Research Institute, Kancheepuram which was originally sanctioned in Government Order first read above and last further continued upto 31.12.2009 in the Government Order second read above for the period from 01.01.2010 to 26.03.2013.

- 2. The Government also sanction for revival for the above post of Steno Typist Grade-II with effect from the date filling up of the post (i.e) from 30.09.2013 and further continuance for the period from 30.09.2013 upto 30.09.2015 or till the need therefor ceases whichever is earlier.
- 3. The holder of the above post is eligible to draw besides pay in the time scale of pay Rs.9300-34800 with Grade Pay of Rs.4200/-, Dearness Allowance, House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.
 - 4. The expenditure shall be debited to the following head of account:-

"2210 – Medical and Public Health – 06 Public Health - 101 Prevention and Control of Diseases - I Non Plan – BY Cancer Control – 01 Salaries. (DPC: 2210–06-101–BY–0101)".

- 5. The Government also ratify the action of the Director of Medical Education in having filled up the above post in anticipation of the Orders for revival from the Government.
