ORDER:

In the Government order first read above, orders have been issued framing guidelines for sanction of financial assistance to poor students at the rate of Rs.25,000/- (Rupees Twenty Five Thousand only) per student from Chief Minister's Public Relief Fund for the entire course of study, to a maximum of 100 students every year.

- 2. In the Government Order second read above, orders have been issued enhancing the number of students for the sanction of financial assistance from 100 to 200 every year, to pursue their professional courses.
- 3. Necessary Proposals have been received from the District Collectors of Villupuram, Salem, Theni, Karur and Namakkal Districts for sanction of financial assistance to seven students from Chief Minister's Public Relief Fund for pursuing M.B.B.S. Course and Diploma in Nursing for the year 2013-2014.

4. The Government, after careful examination of the proposals of the District Collectors at 3 to 9 read above have decided to accept the same and accordingly, sanction the financial assistance of a total sum of Rs.1,75,000/- (Rupees One Lakh Seventy Five Thousand only) at the rate of Rs. 25,000 /- (Rupees Twenty Five Thousand only) per student from the Chief Minister's Public Relief Fund to the following seven students to pursue their entire MBBS / Diploma in Nursing Courses during the year 2013-2014 as a one-time assistance:-.

The Joint Secretary to Government and Treasurer Finance (CMPRF) Department, Chennai-9, is directed to issue a cheque to the total sum of Rs.1,75,000/- (Rupees One Lakh Seventy Five Thousand only) to the seven students at the rate of Rs.25,000/- (Rupees Twenty Five Thousand only) per student, in favour of the Director of Medical Education, Chennai-10 and to send the same to her for disbursement to the students as mentioned in para 4 above.
- 6. The Director of Medical Education is directed to ensure that the above students were not paid any financial assistance from other schemes and then disburse the financial assistance to them after obtaining the stamped receipt from the beneficiaries. The Stamped receipt obtained in original, duly counter signed by the responsible officers not below the rank of Tahsildar may be sent to the Joint Secretary to Government and Treasurer Finance (CMPRF) Department, Chennai-9 with a copy marked to this Department immediately.
