2. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs. 41,80,00,000/- (Rupees Forty one crore and

eighty lakh only) works out Rs.27,86,66,667/- (Rupees Twenty seven crore eighty six lakh sixty six thousand six hundred and sixty seven only).

3. The Mission Director, State Health Society has therefore requested to sanction a sum of Rs.69,66,66,667/-(Rupees sixty nine crore sixty six lakh sixty six thousand six hundred and sixty seven only) towards the Government of India release and State Share for Reproductive and Child Health Flexible Pool and to authorize the Mission Director, National Health Mission and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw the above amount through Treasury mode and to credit into State Health Society Account.

4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.69,66,66,667/-(Rupees sixty nine crore sixty six lakh sixty six thousand six hundred and sixty seven only) towards the Central and State share of Grants –in-aid for Reproductive Child Health (RCH) Flexible Pool including other programmes as arrear during 2017-18.
