ORDER:-

The system of Birth and Death Registration has been revamped from 1.01.2000 and the Tamil Nadu Registration of Birth and Death Rules 2000 have been notified in the Government Order second read above under the revamped system of Birth and Death Registration, Form 1 to Form 15 to be used in the registration process which have also been notified therein.

2. The reporting forms under Registration of Birth and Death have already been standardized by the Government Orders 3rd and 4th read above. The printing and supply of form has been entrusted to the Director of Stationery and Printing, Chennai. In the G.O 7th read above, orders have been issued to the Director of S&P to print and supply the Birth and Death reporting Forms 1,2 & 3 with the provision to include the UID number.

- 3. In the letter 5 & 6 read above, the Registrar General of India has conveyed his approval as per section 30 (i) of the RBD Act, 1969 and to adopt the Birth and Death Certificates Forms 5 and 6 as prescribed by them.
- 4. The Director of Public Health and Preventive Medicine has therefore requested the orders of the Government for Printing and supply of the Birth and Death Certificate Form Nos. 5 and 6 in A3 size in Tamil as prescribed in the specimen annexed to this order.
- 5. The Government examined the proposal of the Director of Public Health and Preventive Medicine and Tamil Nadu Chief Registrar of Birth and Death and accordingly the Government direct the Director of Stationery and Printing to print the Birth and Death reporting Form No.5 and 6 with a provision (to include the UID number) in the specification annexed to the order and supply as per the indent placed by the Director of Public Health and Preventive Medicine.
- 6. This order issues with the concurrence of Tamil Development and Information Department vide its U.O. No. 6863/SP2(2)/2015-1, dated 15.05.2015.
