## ORDER:

In his letter read above, the Director of Medical Education has stated that the Professor and Head of the Institute of Research and Rehabilitation of Hand and Department of Plastic Surgery in Government Stanley Medical College and Hospital, Chennai informed that the institute was started in the year 1971 and it is grown to the present status as "the Centre of Excellence" and they have planned to do Hand Transplant for the amputated patients to improve their quality of life. The hand transplant programme need the State of the art Operating Theatre with laminar flow & epoxide flooring to avoid post operative infections. Aesthetic replacement of hand for amputees for which there is a need for two more operation theatres with latest modern amenities and special wards. Based on requirements, the Director of Medical Education has forwarded the rough cost estimate prepared by the Chief Engineer (Buildings) duly countersigned by him for the construction of Hand Transplant Operation Theatre and Ward at Institute of Research and Rehabilitation of Hand and Department of Plastic Surgery in Government Stanley Medical College and Hospital, Chennai. The floor-wise accommodation details are as follows:-

- 2. The Director of Medical Education has, therefore, requested the Government to issue necessary administrative and financial sanction for a sum of Rs.5.192 crore for the year 2017-18 for the construction of Hand Transplant Operation Theatre and Ward at Institute of Research and Rehabilitation of Hand and Department of Plastic Surgery in Government Stanley Medical College and Hospital, Chennai.
- 3. The Government after careful examination of the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.4.7949 (Rupees four crore seventy nine lakhs and forty nine thousand only) for the construction of Hand Transplant Operation Theatre and Ward at Institute of Research and Rehabilitation of Hand and Department of Plastic Surgery in Government Stanley Medical College and Hospital, Chennai.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4210. Capital Outlay on Medical and Public Health – 01. Urban Health Services – 110. Hospitals and Dispensaries (Including Pharmacy) - State's Expenditure – JA. Buildings – 16. Major Works (DPC 4210-01-110-JA-1602)".

- 5. The expenditure sanctioned in para-3 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by draw of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Chief Engineer (Buildings), Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018-2019 to Finance (B.G.I) Department at the appropriate time without fail.
- 6. This order issues with the concurrence of the Finance Department vide its U.O.No.18686/Health–II/2018, dated: 20.04.2018 and ASL No.105 (one hundred and five).
