ORDER:

In the Government order first read above, the adhoc rules for the post of Technician in the Anaesthetic Department has been framed, which is applicable only to Government General Hospital, Madras and the said rules have been amended in G.O.Ms.No.743 Education and Public Health Department, dated 30.3.1965 making this rule applicable to temporary posts of Technician in Anaesthetic Department in the other hospitals. The Board of Paramedical Education under the control of the Director of Medical Education has since conducted various Para Medical Courses in Government Medial Colleges. In order to provide employment opportunities to the persons who have undergone paramedical certificate course and to appoint the trained personnel in the posts of Technician in Anaesthetic Department in Government Medical College Hospitals, the existing rules in respect of method of appointment for the post of Technician in Anaesthetic Department have to be amended.

2. The appended Notification will be published in the Tamil Nadu Government Gazette.

APPENDIX.**NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Education and Public Health Department Notification S.R.O. No. A-77 of 1962 at pages 84-85 of Part V of the Fort St. George Gazette, dated the 14th February 1962, as subsequently amended.

AMENDMENTS.

In the said Rules.-

(1) for rule 2, the following rule shall be substituted, namely:-

“(2). Appointment.- Appointment to the post shall be made as follows:-

- (i) By transfer from the holders of the post of Theatre Assistants in the Tamil Nadu Medical Subordinate Service; and
- (ii) By direct recruitment:

Provided that appointment by transfer and by Direct recruitment shall be in the ratio of 1:1.”;

(2). in rule 4, for the “TABLE”, the following Table shall be substituted, namely:-

“TABLE

<u>Method of Recruitment</u> (1)	<u>Qualification</u> (2)
(i) Transfer from the holders of the post of Theatre Assistants	Must have experience of not less than five years as Theatre Assistant in Operation Theatre.
(ii) Direct Recruitment	(a) A pass in Higher Secondary Course with the Science subjects- <ul style="list-style-type: none"> (i) Physics, Chemistry, Botany and Zoology; or (ii) Physics, Chemistry and Biology; and (b) Must have passed one year Certificate Course in Anaesthesia Technician conducted at Government Medical Institution by the Board of Para Medical Education under the Directorate of Medical Education, Government of Tamil Nadu or King Institute of Preventive Medicine and Research, Guindy or from any other Institution recognized by the State or Central Government.”;

(3). rule 5 shall be omitted;

(4). for rule 6, the following rule shall be substituted, namely:-

"6. Age.- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 30 years of age on the first day of July of the year in which the selection for appointment is made. ";

(5). in rule 7, after the first proviso the following provisos shall be added, namely:-

"Provided further that on and from the 1st June 1988, the monthly pay shall be calculated in the scale of pay of Rs.800-15-1010-20-1150:

Provided also that on and from the 1st June 1996, the monthly pay shall be calculated in the scale of pay of Rs.2650-65-3300-75-4400:

Provided also that on and from the 1st January 2006, the monthly pay shall be calculated in the Pay Band of Rs.4800-10000 with Grade Pay of Rs.1650."
