### ORDER:

In supersession of the orders issued in the Government order fourth read above and Government letter fifth read above, the following orders are issued.

- 2. Assistant Surgeons (both Clinical and Non-Clinical), Assistant Surgeons (Dental), Assistant Lecturers / Assistant Medical Officers are recruited directly by the Tamil Nadu Public Service Commission following the rule of reservation of appointment (General Rule 22).
- 3. The above mentioned posts come under Group B Category. According to the Government order second read above, the posts viz., Assistant Surgeons (Both clinical and Non clinical), Assistant Surgeons (Dental), Assistant Lecturers / Assistant Medical Officers (Siddha/ Ayurveda/ Unani and Homoeopathy) under the Group B category, have been brought under the list of posts other than Executive posts and Ministerial.

- 4. The posts of Assistant Surgeons (both Clinical and Non- Clinical), Assistant Surgeons (Dental), Assistant Lecturers / Assistant Medical Officers (Siddha) are governed by the Special Rules for the Tamil Nadu Medical Service (Section 21 Tamil Nadu Medical Service in Tamil Nadu Service Manual, Volume II).
- 5. According to rule 10 of the Special Rules for the Tamil Nadu Medical Service, Assistant Surgeons (both Clinical and Non- Clinical), Assistant Surgeons (Dental) recruited by the Tamil Nadu Public Service Commission, have to pass the Account test for Executive Officers within the period of their probation. The Assistant Lecturers/ Assistant Medical Officers (Siddha/ Ayurveda Unani and Homeopathy) recruited by the Tamil Nadu Public Service Commission are governed by the adhoc rules notified in the Government orders first and third read above. According to rule 9 of the Adhoc rules, Assistant Lecturers/ Assistant Medical Officers (Siddha/ Ayurveda/ Unani) and rule 8 of the Adhoc rules of the Assistant Medicai Officer (Homoeopathy) had to pass Account Test for the Executive Officers within the period of probation.
- 6. In view of the above rule position, the Government have decided to classify the posts viz., Assistant Surgeons (both clinical and non-clinical), Assistant Surgeons (Dental) and Assistant Lecturers / Assistant Medical Officers (Siddha/ Ayurveda/ Unani and Homoeopathy) as Executive posts for the purpose of applying the yardstick prescribed for verification of physical standards for holding Executive posts. They accordingly direct that the posts of Assistant Surgeons (both Clinical and Non-Clinical) Assistant Surgeons (Dental) Assistant Lecturers / Assistant Medical Officers (Siddha/ Ayurveda/ Unani and Homoeopathy) be classified as 'Executive Posts' and brought under the list of Executive Posts annexed to G.O.No.34, Personnel and Administrative Reforms (Per) Department, dated 12.01.1983.
- 7. The standard of vision required for appointment to the post of Assistant Surgeon / Assistant Lecturer in the Tamil Nadu Medical Service as Standard III is included.
- 8. Necessary amendment to G.O.(Ms) No.34, Personnel and Administrative Reforms Department, dated 12.01.1983 will be issued separately.
- 9. This order issues with the concurrence of the Personnel and Administrative Reforms (S) Department vide its U.O.No.21886/C1/2015, dated 04.06.2015.
