ORDER:

In the Government Order first read above, the Government have accorded sanction for the establishment of Yoga and Naturopathy Life Style Clinic in 31 District Headquarters Hospital and 18 Medical College Hospitals at a total cost of Rs.9.60 Crore.

2. In the letter second read above the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has informed that the District Headquarters Hospital, Thiruvannamalai has become Medical College Hospital and Government Hospital, Cheyyiaar has been made as District Headquarters Hospital. The Yoga and Naturopathy Life Style Clinic sanctioned to District Headquarters Hospital, Thiruvannamalai is presently functioning at Medical College Hospital, Thiruvannamalai (which was Headquarters Hospital, Thiruvannamalai) with effect from 7.10.2014 consequent on the joining duty of the Assistant Medical Officer (Yoga and Naturopathy). The duty pay of the said Assistant Medical Officer (Yoga and Naturopathy) could not be claimed by the Dean, Medical College Hospital, Thiruvannamalai as the Yoga and Naturopathy Life Style Clinic has been sanctioned under District Headquarters Hospital Head of Accounts. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has informed that only by bringing the above Yoga and Naturopathy Life Style Clinic, Thiruvannamalai to Medical College Hospital side and changing the Head of Account accordingly, the duty pay of the staff attached to the clinic can be claimed by Dean, Medical College Hospital, Thiruvannamalai and that too from the date of issuance of appropriate Government Orders.

- 3. Hence, the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has requested that the Yoga and Naturopathy Life Style Clinic sanctioned to District Headquarters Hospital, Thiruvannamalai may be changed as Yoga and Naturopathy Life Style clinics at Medical College Hospital, Thiruvannamalai, and the budget provision for one clinic (i.e) of Rs.19.61 lakhs may be transferred from District Headquarters Hospital Head of Account to Medical College Head of Account.
- 4. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has also requested that the name of the Madurai Medical College Hospital, Madurai as mentioned in the above G.O. may be changed as Government Rajaji Hospital, Madurai.
- 5. The Government after careful examination, issues the following amendment to the Government order first read above.

AMENDMENT

- i) In Sl.No.23 of the annexure 1 of G.O., the existing words "District Headquarters Hospital, Thiruvannamalai" shall be substituted as "Government Medical College Hospital, Thiruvannamalai".
- ii) In Sl.No.6 of the annexure II of G.O., the existing words "Madurai Medical College Hospital, Madurai" shall be substituted as "Government Rajaji Hospital, Madurai".
- 6. The expenditure required for the Yoga and Naturopathy Life Style Clinic at Government Medical College Hospital, Thiruvannamalai shall be debited under the following Head of Account:
 - 2210 Medical and Public Health-02. Urban Health Services- Other Systems of Medicine-200. Other Systems I. Non-Plan AD. Yoga and Naturopathy Lifestyle Clinics in Medical College Hospitals.
- 7. This orders issues with concurrence of Finance Department vide its U.O.No.30464/Health-I/2015-1, dated 6.06.2015.
