The holder of the posts besides the pay in the time scale of pay of Rs.15600-39100 with Grade Pay of Rs.7600/- (presently drawing the pay of Rs.37400-67000 with Grade pay of Rs.8700) shall be eligible to draw Dearness Allowance, House Rent Allowance and other Allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.
