ORDER:

In the Government Order first read above, orders have been issued sanctioning of Rs.7.00 crore for the purchase of CT scan machine to Government Headquarters Hospital at Pollachi in Coimbatore District, Kovilpatti in Thoothukudi District, Kallakurichi in Villupuram District and Wailajah in Vellore District under state specific needs grants recommended by 13th Finance Commission.

2. In the letter second read above, the Director of Medical and Rural Health Services has requested for Procurement and supply of one C.T. scan machine to the Government Hospital, Gopichettipalayam, Erode District through the Tamil Nadu Medical Services Corporation limited, Chennai and requested the financial sanction of Rs.1.61 crore out of the balance amount available under 13th Finance Commission grants.

3. The Government after considering the approval of the High Level Monitoring Committee have decided to accept the proposal of the Director of Medical and Rural Health Services and accord sanction of Rs.1,61,00,000/- (Rupees One Crore and Sixty One Lakh only) for the procurement and supply of one CT.scan Machine, out of the balance amount available under 13th Finance Commission grants to Government Hospital, Gopichettipalayam, Erode District through the Tamil Nadu Medical Services Corporation limited, Chennai under the scheme "Health infrastructure".

4. The expenditure sanctioned in para 3 above, shall be debited to the following head of account:

"2210 – Medical and Public Health – 80 General – 800 Other Expenditure – II State Plan – JG Improvement of Health Infrastructure by using 13th Finance Commission Grant – 19 Machinery and Equipment - 01 Purchase"

5. The expenditure sanctioned in para 3 above, shall constitute an item of "New Instrument of Service" and the approval of legislature will be obtained in due course. Pending approval of legislature the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the contingency fund will be issued by Finance (BG-I) Department. The Director of Medical and Rural Health Services shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Director of Medical and Rural Health Services shall also send necessary explanatory notes to include the above expenditure in the supplementary estimate for the year 2014-2015 to Finance (BG-I/ Health-II) Department at the appropriate time without fail.

6. The Director of Medical and Rural Health Services is directed to procure and install the equipments through Tamil Nadu Medical Services Corporation Limited., Chennai. Further the amount sanctioned towards purchase of equipments shall not be paid in cash but shall be credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited, Chennai:-
