ORDER

The Mission Director, State Health Society in his letter third read above has stated that Government issued orders in G.O. (Ms) No.36 Health and Family Welfare Department, dated 21.01.2012 for construction of New building to Primary Health Centre, Chendur, Villupuram District. He has issued Revised Administrative Sanction for additional funds of Rs.13.00 lakh for the construction of new buildings in respect of the above PHC due to change of the schedule of rates as approved in the PIP.

- 2) The Mission Director, State Health Society has further stated that as per directions issued in G.O. (Ms) No.116 Health and Family Welfare Department, dated 25.03.2011 the approved additional fund of Rs.13 lakh has been remitted to the receipt head of account of Government of Tamil Nadu vide Chalan No.1742 dated 11.10.2013 of State Bank of India, Treasury Branch, Chennai.
- 3) The Mission Director, State Health Society has requested the Government to issue orders as follows:
 - i. The additional funds of Rs.13 lakh already remitted to Government account may be sanctioned to Public Works Department for the execution of civil works at the Chendur PHC, Villupuram District.
 - ii. The Engineer in Chief and Chief Engineer (Buildings), Public Works Department (PWD), Chennai-5 may be authorized to issue orders to the concerned Executive Engineer of PWD division (Medical Works) for drawing the funds under the head of account "4211-00 Capital out lay on Family Welfare 103 Maternity and Child Health Schemes shared between Central and State"
 - iii. The drawal of funds may be allowed in this regard, pending provision funds in RE/FMA 2013-14, as the funds had been already remitted to Government
- 4) The Government after careful consideration has decided to accept the proposal of the Mission Director, State Health Society and they accordingly sanction an amount of Rs.13 lakh (Rupees Thirteen lakh only) to the Chief Engineer (Buildings), PWD, Chennai-5 for execution of civil works in the PHC at Chendur, Villupuram District.
- 5) The expenditure sanctioned in para 3(i) above shall be debited to the following head of account:

"4211-00-Capital outlay on Family Welfare – 103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan-III. Centrally Sponsored – SA – National Component – Reproductive and Child Health Project – 16 Major Works.
