From the Director of Medical Education, Chennai, Letter Ref. No.33205/P&DI/1/2017, Dated 15.05.2017 and 03.10.2017.

ORDER:-

The Director of Medical Education, Chennai in his letters read above has sent the proposal for the construction of a part of First floor and Second floor (Operation Theatre and Post Operative Ward) over the existing Ground floor of Ophthalmology Block in Government Mohan Kumaramangalam Medical College Hospital, Salem.

- 2. The Director of Medical Education has stated that the Department of Ophthalmology is functioning in Government Mohan Kumaramangalam Medical College Hospital at Salem. The existing Ground floor building is having Out-Patient Department, Special Clinic Ward (Cornea, Retina, Glaucoma, Squint, Neuro Ophthal, Orbit and Oculo-Plasty Low Vision Aids) for infected cases and Septic Operation Theatre. The Out-Patient Department, the pre-operative wards and the main operation theatre are closely situated in the ground floor so that there is a possibility for increasing the risk of SEPSIS in Operation Theatre. To maintain good aseptic standards in the Operation Theatre, it should be constructed in the Second floor along with Post Operative Wards. Further, the Dean, Government Mohan Kumaramangalam Medical College Hospital, Salem has furnished the details of the inspection conducted by the Medical Council of India authorities and necessary justification for the construction of a part of First floor and Second floor (Operation Theatre and Post Operative Ward) over the existing Ground floor of Ophthalmology Block in Government Mohan Kumaramangalam Medical College Hospital at Salem.
- 3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by the Chief Engineer (Buildings), Public Works Department, Trichy Region, Tiruchirappalli and requested the Government to accord administrative and financial sanction for the construction of a part of First floor and Second floor (Operation Theatre and Post Operative Ward) over the existing Ground floor of Ophthalmology Block in Government Mohan Kumaramangalam Medical College Hospital at Salem at an estimated cost of Rs.338.80 lakh for the year 2017-2018, by adding 10% escalation charges on the schedule of rates for the year 2016-2017.

- 4. The Government, after careful examination of the proposal of the Director of Medical Education, accord administrative and financial sanction for a sum of Rs.3,09,00,000/- (Rupees Three crore and nine lakh only) for the construction of First and Second floor (Operation theatre and post operative ward) over the existing ground floor of Ophthalmology Block in Government Mohan Kumaramangalam Medical College Hospital, Salem.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account (Demand 39 02):-

"4210. Capital Outlay on Medical and Public Health — 01. Urban Health Services — 110. Hospitals and Dispensaries (including Pharmacy) - State's Expenditure — JA. Buildings — 16. Major Works. (DPC 4210 — 01 — 110 — JA - 1602)"

- 6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund, orders regarding which will be issued by Finance (BG-I) Department. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimates for the year 2018-2019 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department, directly an application in Form A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order to Finance (BG-I) Department along with a copy of this orders. Orders for sanction of an advance from the Contingency fund will be issued from Finance (BG-I) Department. The Engineer in Chief (Buildings) and Chief Engineer (Buildings), Public Works Department, Chennai is also directed to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2018-2019 to Finance (BG-I) Department at the appropriate time without fail.
- 7. This order issues with the concurrence of Finance Department, vide its U.O. No.19259/Health-II/2018, dated 27.04.2018 and ASL No.151 (One hundred and fifty one).
