From the Mission Director, State Health Society, Letter R.No.3144/A2/SHS/2014, dated:23.5.2014.

ORDER:

The Mission Director, State Health Society in his letter read above has informed that the Centrally Sponsored Schemes like NHM through the Treasure route as part of the State plan and requested to provide for central share of NHM in the state budget. Government of India in their letter dated 9th May, 2014 has transferred and credited a sum of Rs.154.80 crore in to state Government account as its 75% of grants-in-aid (first instalment) for the financial year 2014 -15 as indicated below:

Government of India has requested to ensure that 25% of State share based on the release of funds by Government of India have to be credited to appropriate accounts.

2) The Mission Director, State Health Society has also stated that, based on the 75% of the Government of India share amount of Rs.154.88 crore in to State Government Account and the corresponding 25% of the State Share on the above Government of India releases is worked out to Rs.51,62,66,667. Total amount under RCH and NRHM flexible pool schemes share between Central and State Rs.206,50,66,667. He has stated further that, since Government of India has transferred the grants to State Government as first installment, for drawal of amount through Treasure route from 2014-15, and due to urgency the amount of Central share and State share may be drawn under this following Head of account. After the creation of the new head of Account the sanctioned amount under this head will be adjusted by transfer entries made by the State Health Society.

- 3) The Mission Director, State Health Society has requested that, in order to implement the schemes under RCH Flexible Pool and Mission Flexible Pool for the year 2014-15, he has requested the Government to issue orders for the release of Government of India funds as well as the State share so as to enable to draw the funds through treasure mode. He has requested the Government to authorize the Mission Director, State Health Society and Project Director, Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.206,50,66,667 under National Health Mission through treasure mode.
- 4) The Government after careful consideration have decided to accept the above proposals and accordingly sanction a sum of Rs.154,88,00,000 (Rupees one hundred and fifty four crore and eighty eight lakh only) being 75% Central Grants in Aids of National Health Mission and a sum of Rs.51,62,66,667 (Rupees fifty one crore sixty two lakh, sixty six thousand, six hundred and sixty seven only) being 25% of State Share of National Rural Health Mission as matching grants to the State Health Society, Tamil Nadu to implement the above schemes approved under National Health Mission for the year 2014-15.
- 5) The amount sanctioned in para 4 above shall be debited to the following head of account:

- 6) The Mission Director, State Health Society and Project Director, Reproductive and Child Health Project, Chennai-6 is directed to incur the expenditure from the funds provided in B.E. 2014-15 under the head of account said above.
