- 3. In the Government Order second read above, the Government of India Share of Rs. 23,80,00,000/- only (Rupees Twenty three crore and eighty lakh only) was sanctioned.

The Mission Director, State Health Society has therefore requested to issue orders for the release of a sum of Rs.15,86,66,667 /- (Rupees Fifteen crore eighty six lakh sixty six thousand six hundred and sixty seven only) towards the State Share for Grants-in-Aid for Health System Strengthening under National
