Indian Medicine and Homoeopathy Department – Creation of Non-Teaching Staff for Government Yoga and Naturopathy College, Chennai – Sanctioned – Filling up of Demonstrator (Anatomy-1 post) and Demonstrator (Yoga-2 posts) – through Medical Services Recruitment Board in time scale of pay – Permission – Granted – Orders – issued.

ORDER:

In the Government Order first read above, the Government have ordered that all Direct Recruitment under the control of Health and Family Welfare Department made through Employment Exchange henceforth will have to be made only through Medical Services Recruitment Board (MRB).

- 2. In the Government Order second read above, the Government have accorded sanction for the creation of certain posts for the smooth functioning of Government Yoga and Naturopathy Medical College, Chennai-106. Among others the Government have sanctioned 2 posts of Demonstrator (Yoga) and 1 post of Demonstrator (Anatomy) in the time scale of pay of Rs.15600-39100+5400.
- 3. Based on the Government Order second read above, the Principal, Government Yoga and Naturopathy Medical College has furnished the qualifications for the above posts as prescribed by Tamil Nadu DR. M.G.R Medical University, Chennai as follows:-

b)	Demonstrator (Yoga)	Regular 4 ^{1/2} years Diploma in Naturopathy from
		Osmania University – N.D. (Osm) / regular BNYS
		Degree from recognised University; Candidate should
		have valid Medical Registration from the Tamil Nadu
		Board of Indian Medicine, Government Tamil Nadu
		under Class 'A' Practitioner.

- 4. In the reference third read above, the Commissioner of Indian Medicine and Homoeopathy has stated that the sanctioned post of Demonstrator (Anatomy and Yoga) in the Tamil Nadu Medical Services are coming under the purview of Tamil Nadu Public Service Commission. The adhoc rules for the post of Demonstrator (Anatomy and Yoga) sanctioned to Government Yoga and Naturopathy Medical College, Chennai are yet to be framed. She has also stated that the necessary proposal for framing the adhoc rules for the above newly created post (viz. Demonstrator (Anatomy) and Demonstrator (Yoga) will be sent to Government for approval. Due to pending framing of adhoc rules the Commissioner of Indian Medicine and Homoeopathy has requested to permit to fill up the post of Demonstrator (Anatomy-1 post) and Demonstrator (Yoga-2 post) through Medical Service Recruitment Board in the time scale of pay of Rs.15600-39100+GP 5400.
- 5 The Government have examined the proposal of the Commissioner of Indian Medicine and Homoeopathy carefully and decided to accept it. Accordingly, the Government permit the Commissioner of Indian Medicine and Homoeopathy to fill up Demonstrator (Anatomy-1 post) and Demonstrator (Yoga-2 posts) in Government Yoga & Naturopathy Medical College, Chennai through Medical Service Recruitment Board in the regular scale of pay of Rs 15600-39100 Grade pay 5400 on adhoc basis till regular recruitment is made, subject to the condition that the candidates appointed on adhoc basis shall not be continued in service beyond one year i.e their appointment on adhoc basis has to be terminated before completion of one year. The same persons may be re-appointed afresh after small breaks in continuous service as provided in the above said rule till the regular candidates from Medical Services Recruitment Board join duty i.e break in service for every completion of one year of temporary service. The Commissioner of Indian Medicine and Homoeopathy is also instructed to take necessary steps for framing of adhoc rules to the above posts within six months period as per the instruction issued in G.O.(Ms).No.120, Personnel and Administrative Reforms (S) Department, dated 29.09.2011.
