ORDER:

In the letter second read above, the Director of Medical and Rural Health Services has stated that the Mission Director, National Health Mission has informed that most of the National Health Mission contract Dental Surgeon posts sanctioned in various Government Orders are kept vacant as sufficient candidates are not available as per communal roster at district level and that it has been decided the contractual posts of Dental Surgeons under National Health Mission schemes may be filled up by the Director of Medical and Rural Health Services who is the appointing authority, duly following the State Level Communal Roster, by referring G.O.(Ms)No.220, Health and Family Welfare (EAP.II.2) Department, Dated: 03.10.2013 in which the Government have issued orders to fill up the posts of AYUSH Doctors by the Commissioner of Indian Medicine and Homeopathy at State Level.

2. The Director of Medical and Rural Health Services has therefore requested the Government to issue necessary instructions on the request of the Mission Director, National Health Mission with regard to filling up the National Health Mission Contractual Dental Surgeon posts in Primary Health Centres and Government Hospitals by the Director of Medical and Rural Health Services duly following the State level Communal Roster.

3. In the letter third read above, the Director of Public Health and Preventive Medicine has also requested the Government to issue necessary orders to permit the Director of Medical and Rural Health Services to appoint the Dental Surgeon, as per guidelines.

4. The Government have examined the request of the Director of Medical and Rural Health Services and Director of Public Health and Preventive Medicine in

para 2 & 3 above respectively. Accordingly, the Government issue the following orders:-

- (i) The Director of Medical and Rural Health Services shall invite applications for selection of candidates for the post of contract Dental Surgeons by following the State Level Communal Roster, by issuing advertisements in atleast 2 Newspapers out of which one must be in vernacular language having wide circulation in the State apart from calling for the list from the Employment Exchange as per the guidelines issued in G.O.(Ms)No.44, Labour and Employment (T2) Department, dated 11.03.2015.
- (ii) The candidate shall be selected by following the State Level Communal Roster.
- (iii) The Director of Medical and Rural Health Services shall recommend the names of the eligible candidates to the concerned District Health Society.
- (iv) The concerned District Health Society shall issue the appointment order to the selected candidates.
