#### **ORDER:**

In the Government Order first read above, orders were issued to amend the Special Rules for the Tamil Nadu Medical Service, so as to govern the post of Director of Family Welfare. Now the Director of Medical and Rural Health Services in his letter second read above has suggested that to avoid unnecessary litigation while preparing the panel from the holders of the post of Additional Director of Medical and Rural Health Services in speciality line i.e. Leprosy and Thoracic Medicine, the above rule needs to be amended.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Service (Section 21 in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall come into force on 23.06.2014.

### **AMENDMENT**

In the said Special Rules, in Part II, under the heading "Branch – I – Medical", in rule 3, in sub-rule (a), under the heading "SPECIAL CLASS", in the Tabular column, against the item I in column (1), for the corresponding entry in column (2), the following entry shall be substituted, namely:-

"Promotion from among the holders of the post of Additional Director of Medical and Rural Health Services in General line only"
