ORDER:-

In the Government order first read above sanction was accorded for the establishment of two new Regional Public Health Water Analysis Laboratories at Tiruchirapalli and Tirunelveli. In the G.O. second read above sanction was accorded for creation of certain posts to the two water analysis Laboratories at Tiruneveli and Tiruchirappalli temporarily for a period of one year from the date filling up of the post or till the necessity ceases whichever is earlier.

In the letter third read above the Director of Public Health and Preventive Medicine has stated that the following numbers. of excess staffs are available in the existing Water Analysis Laboratory, Guindy, Chennai and has therefore requested the Government to issue orders permitting him to redeploy the excess staff available in the Water Analysis Laboratory, Guindy, Chennai to the newly established Regional Public Health Water Analysis Laboratories at Tiruchirapalli and Tirunelveli for smooth functioning:-
