### **ORDER:**

The Mission Director, National Health Mission has reported that the proposal for Construction of the Comprehensive CEmONC Block with a total of 100 beds at Government Medical College Hospital (GMCH) Sivaganga at a total cost of Rs.1000 lakhs ( Rupees Thousand lakhs only) with an initial provision of Rs. 500.00 lakhs at 50% of total cost of Civil works.

2. In the G.O first read above, among others, a sum of Rs. 50,00,00,000/- ( Rupees five crore only) was sanctioned for execution of Civil works to construct CEmONC block, with a total of 100 beds at Government Medical College Hospital (GMCH),Sivaganga.

3. The Mission Director, State Health Society has reported that the further funding of a sum of Rs. 100.00 lakhs, at 10% of total requirement of Rs. 1000 lakhs required for construction of the comprehensive CEmONC Block with a total of 100 beds in Government Medical College Hospital (GMCH) Sivaganga under National Health Mission has been approved in the Supplementary PIP 2014-15 and the same has been remitted into Government of Tamil Nadu account, under receipt head of account vide challon No.1071, dated: 02.02.2015 of State Bank of India, Treasury Branch , Thousand Light, Chennai.

4. The Mission Director, State Health Society has therefore, requested the Government

- i. to sanction a sum of Rs.100 lakhs (Rupees Hundred lakhs only) for execution of civil works required for Construction of the Comprehensive CEmONC Block with a total of 100 beds in Government Medical College Hospital (GMCH) Sivaganga under National Health Mission funds already remitted into the State Government Account in addition to the fund of Rs.500.00 lakhs sanctioned in G.O first read above
- ii. to permit the Mission Director, State Health Society for incurring the above expenditure by drawing funds available in the BE 2015-16;and
- iii. to permit the Engineer in Chief ( Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the civil works.

5. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly,

- i. Sanction a sum of Rs. 1,00,00,000/- ( Rupees One crore only) for construction of comprehensive CEmONC Block with a total of 100 beds in GMCH Sivaganga at a total cost of Rs. 10,00,00,000/- ( Rupees Ten crore only) funds already remitted into the State Government Account in addition to the fund Rs. 50,00,00,000/- ( Rupees Five crore only) sanctioned in G.O first read above.
- ii. Permit the Mission Director, State Health Society for incurring the above expenditure by drawing funds available in the BE 2015-16, and
- iii. the Engineer in Chief and Chief Engineer ( Buildings) Public Works Department is permitted to issue orders to the Executive Engineers of the concerned divisions for carrying out the Civil Works required for construction of comprehensive CEmONC Block with a total of 100 beds in GMCH Sivaganga.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-

“ 4211 - 00 - Capital Outlay on Family Welfare -103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan – III Centrally Sponsored – SA – National Component – Reproductive and Child Health Project – 16 Major works”. (DPC 4211-00-103-SA-1608)
