Order:

In the Government Order first read above, the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate, Chennai has been delegated with financial power on par with powers delegated to Deans and Head of Departments of Institutions under the control of the Director of Medical Education.

2. In the letter 2nd read above, the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate, Chennai has stated that currently, all the procurements above the value of Rs.10 lakh, as well as equipment costing more than Rs.5 lakh per unit, and drugs / consumables / surgical costing more than Rs.10 lakh are necessarily being procured through the Tamil Nadu Medical Service Corporation. The above Hospital handles mainly super speciality cases. Many speciality drugs are not forming part of the Tamil Nadu Medical Service Corporation essential / speciality drugs list. Moreover, the Hospital is catering to treatments in super specialities. Even the basic treatments are costly due to speciality drugs/ consumables. In the absence of the adequate financial powers, it will not be possible to utilize the fund for the benefit of the patients. Hence, he has requested the Government to enhance the financial powers delegated to the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government

Estate, Chennai for the benefit of the poor and needy patients and smooth functioning of the hospital as indicated below:-
