#### ORDER:

The Mission Director, National Health Mission has reported that the proposal with a total budgetary requirement of Rs.4000.00 takhs with an initial provision of Rs.400.00 takhs at 10% of total requirement of Rs.4000.00 takhs for Civil works for the year 2013-14 for strengthening the Medical College Hospital wings in the two Medical College Hospitals, namely Tirunelveli and Trichy was approved by National Programme Co-ordination Committee (NPCC) of Government of India. The Executive Committee approved the same in its 24<sup>th</sup> meeting held on 08.10.2014 and the amount of Rs.400 takhs remitted into Government of Tamil Nadu account, under receipt head of account vide ChallanNo.616, dated: 26.04.2014 of State Bank of India, Treasury Branch, Thousand Light, Chennai, as per the Government's guidelines.

2. The Mission Director, State Health Society has added that the fund amounting a sum of Rs.400.00 lakh, at 10% of total requirement of Rs.4000.00 lakhs for both the above two Medical College Hospitals, has been approved for the year 2014-15, on the proposal included in the Supplementary PIP 2014-15, the amount received from Government of India and remitted in to Government of Tamil Nadu account, under receipt head of account vide challan No.606, dated 16.04.2015 of State Bank of India, Treasury Branch, Thousand Light, Chennai, as per the Government's guidelines.

- 3. The Mission Director, State Health Society has therefore, requested the Government.
  - to permit him to execute the civil works for strengthening the Medical College Hospital (MCH) wings of Government Medical College Hospitals, Tirunelvell and Trichy, at a total cost of Rs.4000.00 lakh through Public Works Department
  - to sanction a sum of Rs. 800.00 lakh (Rupees Eight hundred lakhs only) to Public Works Department which has already been remitted into the State Government Account for execution of approved civil works for the years 2013-14/2014-15 for Strengthening of the Medical College Hospital (MCH) wings of Government Medical College Hospitals, Tirunelveli and Tiruchy, and
  - to permit the Engineer in Chief (Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the above work and to allow the drawl of funds in BE 2015-16 under the Head of Account "4211 -00 outlay on Family Welfare".
- 4. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and they accordingly,
  - (i) permit the Mission Director, State Health Society to execute the civil works for strengthening the Medical College Hospital (MCH) wings of Government Medical College Hospitals, Tirunelveli and Trichy, at a total cost of Rs.4000.00 lakhs (Rupees Four Thousand lakh only) for both Medical College Hospitals;
  - (ii) sanction a sum of Rs. 800.00 lakh (Rupees Eight hundred lakhs only) to the Engineer in Chief and Chief Engineer Buildings, Public Works Department, Chennai 5 for execution of civil works required for Strengthening of the Medical College Hospital (MCH) wings of Government Medical College Hospitals, Tirunelveli and Tiruchy for the year 2013-14 and 2014-15,and
  - (iii) The Engineer in Chief Buildings. Public Works Department is permitted to issue orders to the Executive Engineers of the concerned divisions to carryout the above Civil Works by drawing funds in BE 2015-16.

- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-
  - " 4211-00 Capital Outlay on Family Welfare -103 Maternity and Child Health
  - Schemes in the Twelfth Five Year Plan III Centrally Sponsored SA
  - National Component Reproductive and Child Health Project 16 Major works". (DPC 4211-00-103-SA-1608)
