ORDER:

In G.O. (Ms) No.34, Health and Family Welfare Department, Dated: 25.02.2013, accorded permission to the Managing Trustee, Revathi Charity Trust at Tiruppur District to start a new College of Nursing in the name and style as "Revathi College of Nursing" at Tiruppur to conduct B.Sc Nursing course with an annual intake of 50 students from the academic year 2013-2014.

2. The Principal, Revathi College of Nursing, Tiruppur has requested to issue necessary orders for Increase of B.Sc (Nursing) Course from 50 to 100 seats from the academic year 2018-2019.

3. Based on the request, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Nursing College has fulfilled the conditions prescribed by the Government and the Indian Nursing Council, New Delhi for increase of B.Sc (Nursing) Course from 50 to 100 seats. The Director of Medical Education has submitted proposal along with the inspection report / Project Report along with his specific remarks to the Government and requested to issue necessary orders.

4. The Government have examined the case in detail in the light of the recommendation of the Inspection team and the Director of Medical Education and permit the Principal, Revathi College of Nursing, Tiruppur run by Revathi Charity Trust, Tiruppur to apply to the Indian Nursing Council, New Delhi for increase of B.Sc (Nursing) seats from 50 to 100 seats at Revathi College of Nursing, Tiruppur in

S.F.No.214/1Bpt, 214/2Bpt at Revathi College of Nursing, Velayuthampalayam Village & Panchayat, Avinasi Taluk, Tiruppur District from the academic year 2018 - 2019, subject to the following conditions:-

- (a) Admission of students shall be made as per the rules fixed by the Government from time to time.
- (b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.
- (c) The Trust should obtain recognition/ suitability/ affiliation from the Indian Nursing Council, New Delhi, Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University respectively before admitting the students.
- (d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non-compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc.
- (e) The Trust should fulfill the Teacher student ratio as per the norms of Indian Nursing Council, New Delhi.
- (f) The Trust should obtain the building completion certificate from the competent authority for the proposed Nursing College and submit to the Government before admitting the students.

5. The Director of Medical Education is requested to take necessary further action accordingly.
